AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS OF TURNAGAIN VILLAGE HOMEOWNERS ASSOCIATION

(ANCHORAGE RECORDING DISTRICT)

WHEREAS, ARTICLE XV, Section 1 of the Declaration of Covenants, Conditions and Restrictions of Turnagain Village dated February 27, 1997, recorded in the Anchorage Recording District, Third Judicial District, State of Alaska in Book 3048, at Page 230 on April 9, 1997 (the "Declarations") establishes that the Declarations may be amended by an instrument signed by not less than seventy-five percent (75%) of the Unit Owners which is recorded in the Anchorage Recording District, Third Judicial District, State of Alaska;

WHEREAS, 16 Units exist in Turnagain Village as of January 1, 2011.

WHEREAS, at least 12 Unit Owners (75% of the Unit Owners) have consented to this amendment in compliance with the Declarations.

NOW, THEREFORE, BE IT RESOLVED THAT ARTICLE VII, Section 3 of the Declaration is hereby amended to exclude exterior paint and paint preparation of backyard deck flooring as decks have been homeowner modified since original construction, and to exclude maintenance of gutters and downspouts, as gutters and downspouts have been homeowner installed and/or modified. Article VII, Section shall be amended to read:

In addition to maintenance upon Common Elements, the Association shall provide exterior maintenance upon each Unit which is subject to assessment hereunder as follows:

Paint and paint preparation of exterior building surfaces, <u>excluding</u> <u>backyard deck flooring</u>, including common perimeter fences. <u>Unit owners shall be</u> <u>responsible for all painting and maintenance of backyard decks.</u> <u>Maintenance of backyard decks.</u>

gutters, downspouts, trees, shrubs, grass, walks, and other exterior improvements, including the repair and maintenance of the roofs and snow removal from driveways by a licensed, bonded right-of-way permit holder as required by the Municipality of However, such exterior maintenance shall not include repair of driveways, doors, glass, rear yard fences, gutters and downspouts.


