### EASTRIDGE II TOWNHOME ASSOCIATION Resolution 2020-1 SUBJECT: New Construction and Modification Requests

One of the responsibilities of the Board of Directors is to ensure that the Association property is properly maintained and that the governing documents [Declarations, Bylaws and House Rules] are adhered to.

Article V of the Declaration requires that all modification to the property, whether through new construction or alteration be approved by the Board of Directors. The article requires that owners wishing to make alterations to the property must submit their plans, materials, and specifications to the Board.

The Board of Directors at its meeting held August 26, 2020 voted unanimously to make an addition to the necessary plans and specifications submitted by owners making structural additions to their property. The Board of Directors now requires owners submitting plans for new construction of deck extensions, windows, doors, and arctic entries, or other significant construction, submit a structural assessment with their packets.

Upon completion of the project, owners will need to submit to the Board, a copy of the Municipal Inspection and verification of the closed building permit. Failure to supply the closed building permit and inspection will result in a flag on the property which will slow down closing, in the event that the property is sold.
